# THE CENTRAL SERVICE OFFICE OF SOUTHERN COLORADO

There seems to be a misunderstanding about the nature of the Central Office and whether it is a part of A.A. This article is written to clarify the functions of Central Offices and Intergroups.

Intergroups and Central Offices are fundamentally the same thing and provide similar services. In A.A. literature they are discussed as the same thing. The Central Office in Pueblo was established in 1998 and replaced the intergroup that existed at the time. "The Central Service Office of Southern Colorado (CSO) is a service branch of Alcoholics Anonymous including Districts 8, 6 & 3 and will be referred in this charter as "CSO". Its primary purpose is to serve in support of Southern Colorado Groups of Alcoholics Anonymous in their common purpose of carrying the message to the alcoholic who still suffers. The CSO operations are assisted by volunteer personnel whom are guided by the Steering Committee, the Twelve Traditions of Alcoholics Anonymous, and the Twelve Concepts for World Service." The Central Service Office lies outside of the service structure of A.A. which was established as a communication link between the groups and the trustees. The first General Service Conference was held in April 1951. The first Central Office was opened in Cleveland in 1939.



The A.A. Service Manual (BM-31) states: "Intergroup/central offices exist to serve the local groups in their general area. Each Intergroup/central office is autonomous and is part of a network of service outlets and A.A. contacts. While the offices are an important part of A.A., they are not part of the general service structure or a satellite of G.S.O. The vital services they provide include maintaining local meeting information, providing meeting lists and other literature, maintaining websites with local information, and responding to phone calls and other inquiries from those seeking help." Reprinted from The A.A. Service Manual, pg. 6, with permission of A.A. World Services, Inc. Appendix S of the service manual and A.A. Guideline MG-2 provide detailed information about the functions and operations of Intergroup/central offices. All these publications are available at the Central Office. The Central Service Office of Southern Colorado is a non-profit corporation that answers to the will of the groups in its service area (District 3, 6, and 8). The Steering Committee meets on the first Wednesday of the month at 6:00 pm at the CSO. All groups are encouraged to send a representative to the meeting to voice the conscience of their group. If there is something the Office is doing that the group does not agree with or not doing something that the group desires and no representative is sent to the meeting, nothing is going to change. For those who are not able to attend the meeting in person, a Zoom link is available to attend the meeting remotely. Information about the Zoom meeting is available on the CSO website (www.puebloaa.org). The Central Office provides a number of services to the AA community in Southern Colorado.



Your service area covers a large area. Imagine a line that goes from Canon City east to the Kansas border and another line that goes southwest (including the San Luis Valley) to the New Mexico border; that is the service area of the CSO. Some of the services provided by the Office are:

- ☐ Provides a 24/7 hotline for information and 12 Step Calls.
- ☐ Maintain a 12 step call list.
- ☐ Maintains a Bridging the Gap contact list.
- ☐ Provides the only phone number and mailing address in southeastern Colorado that is exclusively for Alcoholics Anonymous.
- ☐ Maintain a meeting directory for all groups in our service area.
- ☐ Maintain a website that provides information and meeting lists. This includes keeping the Meeting Guide App up to date for the meetings in our service area.
- ☐ Provides AA and Grapevine literature.
- ☐ Provides an archive of documents and information from the General Service Board and General Service Office to assist local groups in their efforts to carry the message of AA to the still suffering alcoholic.
- ☐ Hosts various activities and workshops in the local area.

If you have any questions or need any information, come by and visit us. We are open Monday through Friday from 10 am to 4 pm. If you are interested in getting into service, we always welcome volunteers and individuals who want to help on our service committees. For all groups, we ask that you send a representative to our Steering Committee meeting on the first Wednesday of the month at 6 pm. We want to provide the best possible service to groups in the area.
