

Easy Does It





When I arrived in AA, I had no clue what I was in for. It has been a lifetime thing for me. In January of 1980, my father died. He was the elephant in the living room, his abhorrent behavior to my mother, spoiling her rotten with anything she wanted and beating her senseless when she got it. He was conversely a saint in public, a life saving surgeon and generous to a fault. His epitaph says it all, He Gave.

That's not what this is about. I was two weeks short of my 21st birthday. There were two funeral services for my father and between them my two older brothers took me to a sandwich shop on Norwood. We went down a short hallway to a long narrow room in the back. The cigarette smoke was really thick, there were little framed things on the wall with sayings like "think think think" and "Just for Today". I was in the Great Escape.

This is the point of this article. There were many meetings in Pueblo in the Eighties. The people who say there were only a few didn't get out much. At the time the Great Escape was the only meeting at noon. Most meetings at the time were at eight pm. There were more meetings at the state hospital than today. On weekends we had dances on the Alcoholic Treatment Center ward with a DJ in the program. The 3-pont club was downtown on Main at tenth street in a former restaurant building that had been the Mozart. Probation and Parole

offices were on tenth street across the street from where social services is now. There was a meeting there on Wednesday at 8:00 pm called the Great Open Door. That was where everyone went to get their court paper signed. Out on the mesa, at the old St. Joe's, in their education building there was an AA meeting in one room and an Alanon in another room further down the hall. You could tell the AA room because it was the one where people were laughing.

In Belmont the Christ the King Catholic church (X the Rex) had three meetings a week, which included a step study and a big book study. Man did I learn a lot in there. The Parkview CDU was just getting started. For a while, after some drunk drove into the Mozart, through the fireplace on the west side of the building no less, the 3-point club rented space for cheap in the same building occupied by CDU on Club Manor Drive. Tradition 6 anyone? There were still some meetings held at CDU but the club moved down to Clark Street when the counselors wanted to facilitate the AA meetings.

On the south side there were meetings at St. Peters Episcopal church in the basement. There were at least two I remember at 8:00 pm and one on Friday nights from 11:00 to Midnight that was a candlelight meeting. It was a hugely popular young people's meeting. Pueblo west had not been developed enough in early eighties for there to be meetings. The first ones I remember were held in a community center in the middle of the mobile home neighborhood. When smoking in public spaces, we were the first city in the country to have a municipal non-smoking ordinance, became an issue in Pueblo and a certain individual that was a real go-getter came into AA, there was a bloom of early morning, noon and 6:00 pm meetings like the desert after a heavy rain. Many of those meetings kept going for quite a while, and that man is the very best example of service to the program I know of.

There are still some meetings that are not in the printed schedule or available on the app. These meetings are for the select few who feel that their reputations could be irreparably damaged by a breach of anonymity. Back in the day those meetings were often couples meetings and typically met in a closed restaurant or a meditation room at a church.

The moral of this story is that meetings, like alcoholics, come and go. Resentment, schedule changes and other circumstances beyond our control cause change. If a meeting that once thrived is gone, look around the chances are you'll just find those folks in another room. Matt W - Pueblo
